



But what you haven't been told is that the freshwater stickleback actually degenerated instead of evolving. They lost some fins, spikes, and their bony armor plating. This is not evolution at all, even if you look at it in an optimistic way. This is losing what you already have instead of gaining more. This degeneration is due to genetic mutation which is just a fancy term for genetic degradation. Genetic codes are slowly getting destroyed due to copying errors and factors such as radiation and chemicals, like a good blue-print for a house that is slowly getting destroyed. You're not going to end up with a better house, you will end up with a pile of rubble. Our genes have never been observed to improve or evolve or even just to compensate the damage. We will eventually lose so much genetic functions that we will die and go extinct. This had already been predicted by geneticists and they are studying how fast we are degenerating and how soon we will go extinct. Don't worry, it's going to take a long time because our population is huge. But take note that Diabetes, a product of genetic degradation, is already at almost 10% prevalence rate in American population and it is still increasing.

Genetic degradation was already predicted in the Bible when the Bible said "everything is withering" (that includes our gene pool). What we cannot observe is evolution. There is not a single shred of solid

evidence for evolution. The missing links or ancestral forms of animals are still missing so the fossil record or geology strongly disagrees with Evolution, as what Charles Darwin admitted in his book titled Origin of Species. Due to the lack of ancestral forms, all animals appears to just pop into existence overnight without any evolutionary history according to the most famous and notorious atheist and evolutionary biologist, Richard Dawkins (The Blind Watchmaker, pp. 229-230). We know we are created because DNA is information or instruction or a blue-print. Of course, a blue-print doesn't come from randomly scrambling the information on a paper. It can only come from the intelligence of a creator. And since our body is astonishingly and ingeniously designed that no human technology can match it, we can tell how smart our creator is.







2014 Most Notable News: Evolutionary Icons Toppled...Whale Evolution...

The big-picture story of evolution tells that, over millions of years, natural processes produced millions of species from one or a few primitive progenitors. Did this really happen, or did God create separate distinct "kinds" of creatures about 6,000 years ago like Genesis 1 clearly describes?

Mutations are supposed to be evolution's engine since they generate variations from which nature then selects. Several different reports devastated this evolutionary icon. One report revealed the near-impossibility of mutations adding information to DNA, given the discovery that DNA encodes two layers of coding in the same space. Changing one letter affects both codes. Another study revealed that cells would begin removing useless gene sequences long before they had a chance to accumulate enough mutations to evolve into a new and useful gene. A third report concluded that the vast majority of mutations produce too tiny a difference for any natural process to see or select, causing slightly harmful mutations to accumulate far faster than any helpful ones could. All these reports were summarized in a review document released in 2014. [Bhattacharya, D. et al. 2013. Genome analysis of *Elysia chlorotica* egg DNA provides no evidence for horizontal gene transfer into the germ line of this Kleptoplagic Mollusc. *Molecular Biology and Evolution*. 30 (8): 1843-1852.] Any one of these results warns of disaster for evolution's supposed mutation engine, but together they completely shut it down.

Evolution's advocates will have to search for some new icons after taking a beating in 2014. They can no longer justify the claim that whale evolution, gene transfer between unrelated animals, or code-building mutations are scientifically valid.



The profound significance of Mendel's work was not recognized until the turn of the 20th century (more than three decades later) with the independent rediscovery of these laws. 



As shown by their study, most small breeds of dog have two unique markers (SINE element insertion in intron 2 of the IGF1 gene and a SNP allele) not found in either wolves or large breeds." Like other "pure breed" dogs, Chihuahuas suffer from problems that are specific to their breed, Some of those are:

- > A major problem that affects them is the Patella luxation [loose kneecaps], where the kneecap of the dogs rear legs slip out of the grooves.
- >They can suffer from Hypoglycemia [low blood sugar disease].
- > As Chihuahuas have a very small mouth there can be an overcrowding of the teeth.
- >They can suffer from Hydrocephalus [characterized by a build up of fluid around the brain].
- > Collapsing trachea could be a problem [the symptoms include coughing, shortness of breath, and exhaustion].
- > Molera, which is a soft spot on the top of their head [similar to a human baby's soft spot], but most Chihuahuas don't outgrow it, so care must be taken when petting or handling its head.
- > As Chihuahuas have large protruding eyes they may develop an eye problem known as dry eyes. And due to their large eyes and as they are closer to the ground, they are more prone to eye injuries than many other breeds.

Even though most (if not all) dog breeds are the result of artificial selection by humans, they show that a huge variation can be achieved within a species/kind.If the different dog breeds were found as fossils, we may have assumed they were different species. Corroborative evidence. Historical evidence

The Talmud tells us that earlier Balaam had been an adviser to the pharaoh who enslaved the Children of Israel and sought to destroy their male children.

The third century BCE Greco-Egyptian historian, Manetho, also mentions that it was the prophet-adviser to the pharaoh who instigated the enslavement of the Jewish People.

The Midrashic sources also place him in Aram], modern-day Syria, and in the Aegean isles, and in Cush, modern-day Ethiopia . Balaam was an itinerant prophet with a far-reaching reputation..

He is identified as a false prophet by Peter and Jude who believe it. (2 Peter 2:15-16; Jude 1:11).

John the apostle relates the sin of Balaam as fornication to the growth of the church mingles with the world. He believed it. Rev 2-3

God tell us the donkey spoke and Jesus believed it, that settles it.



The angel opened her mouth and spoke through her. This is reiterated by Peter, who identifies the donkey as "a beast without speech" and who "spoke with a man's voice" (2 Peter 2:16).

Balaam was the grandson of Laban the Aramean. The patriarch Jacob lived in Aram and married the two daughters of Laban. Jacob and his wives were returning to the land of Canaan, they stopped in the land of Moab at Succoth. Archaeologists believe that the Jordanian hill called Tel Deir Alla is the site of Biblical Succoth. And, it was here in Tel Deir Alla that evidence of Balaam was found.

Professor Henk J. Franken found a fragment, written on it in bold letters the words:



"the prophet, Balaam son of Beor."

JOSEPH RINGS

Exhibit D: The "Yakov" Joseph's royal seal was discovered at Tell el-Daba, the site of the ancient Hyksos capital at Avaris. This is also the location of Rameses, the place where the Israelites settled (Gn 47:11) and where they departed from (Ex 12:37). In the 13th century BC, long after the Israelites left Egypt. The Austrian team excavating the site found nine scarabs (beetle-shaped amulets) bearing the name of a Hyksos called Jacob-Her dating to ca. 1700 BC. The naked archaeologist, of course, says that this is Joseph's father Jacob. He further contends that these are "seals worn by Joseph's court officials." The scarabs are connected to the high official Joseph. (Bietak 1997: 115).

Jewish historian Josephus says that, at the time of Joseph, there was a Semitic people called "Yakov" ruling Egypt's Nile Delta. He identifies the Hyksos with the Israelites. For over four decades, Professor Manfred Bietak has been digging at Avaris. It is there that he found a statue that may very well be linked to Joseph. The question is: has Professor Bietak found any royal signet rings? And the answer is, yes! What is inscribed on them: "Ykb-Hr."

I mean, after all, this is the only time that the name of the biblical patriarch is inscribed on an Egyptian royal scarab.

Seal with naked man and woman

In 1922 E. A. Sparrow of the University Museum of Pennsylvania discovered a seal near the bottom of the Tepe Gawra Mound levels from Mesopotamia. He estimated that the seal came from about 3000 B.C.

It shows a naked man and a naked woman, both bent over as if they were engaged in intercourse. Behind them, partly broken, is a serpent (see drawing in upper left of image).

The seal is small, only about one inch in diameter, engraved on stone, and now held in the University




